

Tourist Visa Application procedure (For Foreign Spouses of Turkish Citizens)

If you do not fall under visa exemption or e-visa, please read the instructions below and complete the procedure at the consular section in charge.



The Consular Sections are located in Tokyo and Nagoya.

All inquiries and procedures must be handled by the Consular Section with jurisdiction over your place of residence in Japan.

Required Documents for a Tourist Visa Application

All documents must be submitted in English or Turkish, or with an English or Turkish translation.

1. Visa application form

The pre-application must be completed online at:

<https://www.konsolosluk.gov.tr/Visa/Index>

Please make sure that all information entered in the system is correct and complete.

Please make an appointment through the system. Turkish citizen spouses may also make an appointment through the system under the Turkish spouse's name in a different category using their Turkish ID number.



2. Two photographs (5 × 5 cm, white background)
3. One copy of flight reservation (Ticket issuance is not required.)
4. One photocopy of your Turkish citizen spouse's Turkish ID card
5. Original passport (Your passport must be valid for at least 60 days after the last day of your planned stay in Türkiye and also have at least three blank pages for entry/exit stamps and for the visa sticker to be affixed.)
6. Original Japanese Residence Card (Zairyu Card) (It will be returned after being checked at the counter.)
7. One photocopy of your Japanese residence card (Zairyu Card)

8. "Copy of Civil Registration (Nüfus Kayıt Örneđi) of your spouse" or "International Marriage Certificate (Aile Cüzdanı)"
9. Questionnaire for visa application

10. Undertaking and information sheet

11. Visa fee (cash only) Single entry: 9,378 JPY Multiple entry: 28,134 JPY.
Please prepare the exact amount.

Important Notes

- Depending on the spouse's passport nationality, visa processing may take approximately 1-2 months for certain countries. Please submit your application well in advance.
- The applicant must appear in person at the Embassy to apply for a visa.
- If you choose to receive your passport by mail, please submit a stamped, self-addressed return envelope (e.g., Registered Mail (Kakitome) envelope or Letter Pack) when you apply for visa. Please note that we are not responsible for lost mail.
- Visa stickers cannot be affixed to passports sent from abroad.
